Dear Children of God:

As I reflect this morning on the opportunities that God gives to each of us, I am quickly reminded that I am humbly serving as the Chair of the Dayspring Community because someone saw the possibility that I could contribute something to the Dayspring Community in that role. The experience has been phenomenal. I have had the unique opportunity to get to know more Servants and Pilgrims in this Community than I would have ever thought possible. I am constantly amazed how individuals come up to me in this Community when I am out and about and tell me what a difference being a part of the DWTE Community has meant to them and their family. I feel the same way-what a blessing! Thanks be to God for this opportunity. This year has flown by and I cannot believe that it is time according to the bylaws for me to appoint a Nominating Committee of the Board of Directors and to seek willing and able servants to serve on the Dayspring Board of Emmaus. According to the Bylaws: Members desiring election to the Board of Directors or any other office will make this desire known, in writing, to the Chairperson of the Board by August 1 of each year. This information will be provided to the nominating committee for their consideration. Since I am writing to each of you on the 25th of July, which does not give anyone much time to think and pray about whether they might like to serve the Community as a Board member, I am asking that each of you consider this possibility and please contact me if you have any interest in being considered by the Nominating Committee to serve on the Board of Directors of the Dayspring Community, and that you do so prior to 15 August 2013. I have appointed the Nominating Committee according

to the Bylaws already and I would request that anyone with an interest in serving, please contact me by the 15th of August so that I can pass that information along to the Committee in order for the members of that Committee to complete their task in the appropriate time frame provided by the Bylaws.

The Board of Directors commitment is for a three (3) year period of time (so the term would begin on 01 January 2014-31 December 2017) and involves monthly Board meetings on the first Thursday of every month at 6:30p.m. at the Statesboro First United Methodist Church Library. In addition, the following criteria for Board membership is outlined in the Bylaws and will be used to govern the eligibility and selection process: It will be required that all members of the Board of Directors be actively involved in their local church, be members in good standing with the community; be an active participant in all Community activities; have served as an onsite team member, and meet any other qualifications that may be deemed necessary by the Board of Directors.

I apologize again for doing a better job keeping up with the timing on all of this, but if you are led to submit your name for consideration for membership on the Board, please feel free to contact me and to do so prior to 15 August 2013.

Thank you for your servant hearts and your commitment to the Dayspring Community and to God.
